### RA/18/20 – Matter arising from the R&A meeting held on 04 January 2018

[Broadview and Hinton Park fencing](#) – The work on the wire fencing at Broadview is still awaiting the removal of the temporary site fencing from the adjacent building site.

The replacement of the wooden fencing at Broadview is currently ongoing.

It was agreed to reassess the situation with regards to the Hinton Park fencing in April.

[Wildflower verge planting / licence etc.](#) – Nothing further heard from Hampshire County Council (HCC) with regards to a refund of the licence fee, or clarification on how to stop the wildflower area being cut by HCC's contractors.

[Cricket net ropes and promotion](#) – The Clerk is checking with Kingsclere Cricket Club as to what they use to secure their nets.

[Church Green football](#) – It was agreed to ascertain whether any extra cutting will be required, and at what cost.

[Abbots Worthy noticeboard and headers](#) – Still awaiting agreement for installation.

[Eversley Park mobile shelters](#) – It was agreed to remove this item until an update is available.

[Bin at Hinton Park](#) – The final placement is to be decided on the walkabout with our Grounds Contractor on the 2<sup>nd</sup> February.

#### RA/18/21– Tree works / maintenance

[Tree Inspections 2018](#) – The inspections are currently ongoing with Fraser Road, Church Green and Lovedon Lane burial ground already completed.

[Broadview / Nations Hill](#) – The replacement trees have now been planted.

[Tree & Wall Work at Kim Bishop Walk](#) – At the suggestion of potential contractors, it was agreed to ask HCC whether a small deviation in this footpath is possible.

[Diversion of footpath 5 at Eversley Park](#) – It was agreed to look at this footpath on the walkabout with our Grounds Contractor. All other members are to look at the path to give a view and to discuss at next meeting.

#### RA/18/23 – Dog waste issue

[Signage and Stencils](#) – All but one of the stencils has now been applied. Our Maintenance Contractor has been instructed to install the signs on existing fixture by the 28<sup>th</sup> February 2018.

Cllr White is to liaise with Kings Worthy Primary School (KWPS) to see if there has been any improvement from school parents point of view.

[Dog waste bins](#) – WCC have replaced the broken dual use bin at Broadview and therefore it was agreed to proceed with the removal of the Broadview red dog waste bin.

WCC have been contacted to request the change of the dual use bin adjacent to the King Charles pub from a 120L bin, to a 240L bin.

It was also agreed to ask the residents of Firs Crescent whether the red dog waste bin at the end of Blackberry Fields is well used and whether they would be happy for us to remove it.

It was also agreed to ascertain who owns the red dog waste bin at the bottom of Nations Hill.

[Pump track & skateboard ledge](#) – A representative of Street Reach will be attending the next Parish Council to discuss the pump track and skate facilities.

[Eversley Park path](#) – awaiting a site visit by the contractor.

[Eversley Park extension / allotments / path / running marker posts](#) – Cllrs White and Hallisey are to discuss this at the HAB site meeting on the 7<sup>th</sup> February.

[Seats](#) – Seat installation at Broadview is now complete.

[Defibrillators \(AEDs\)](#) – Agreement has now been obtained and the installation of the unit at Tesco Express will be taking place shortly.
