#### P/21/068 – Public question time

A parishioner raised the current outstanding reinstatement works at 17 Sycamore Drive following the refusal of the original planning application following a planning appeal. Whilst a recent revised planning application has been permitted, the removal of the previously completed works that were refused has not yet taken place. The parishioner had been informed this would be done by 23<sup>rd</sup> September 2020 but this reinstatement work has still not started.

#### (Cllr Biddle arrived at this point)

Cllr Gordon stated that the case officer who was handling this application has now left but the recently permitted application was done with input from the case officer.

**Action:** Cllr Gordon will contact the planning department to chase this as an enforcement matter.

The parishioner also noted that they felt the development on Top Field had been done well but requested an update on the status of the proposed Hookpit Farm Lane layby, by Tesco Express.

Cllr Gordon stated that the site fencing is still up and it does not appear that the land has yet been handed over. The pathways around the open space are not yet up to standard. The Tesco junction is still planned and money is being allocated but we are not aware of any timings on when the work will commence.

# P/21/074 – Speed sign report

Cllr Cossburn noted that there had been a ~2% drop in speeding on Springvale Road since the last deployment.

**Action:** It was agreed that a webpage will be created for the speed sign and updates will be published regularly.

Cllr Biddle noted that she had received an email from a Church Lane resident about the safety of Church Lane.

Cllr Gordon stated that he has seen groups of children using the footpath which is narrow and has multiple entrance/driveways across it. The multiple access points often result in an uneven surface due to the slope. Hampshire County Council (HCC) were previously only willing to install blue HGVs signs.

It was noted that due to the width of the road it would be hard to find a suitable site to deploy the Parish Council's speed sign.

**Action:** It was agreed that Cllr Gordon will speak to the highways safety officer to request improvement for Church Lane.

**Action:** Councillors will prepare a list of highways works to be proposed and works that have been refused or are outstanding. This will be passed to Cllr Gordon by the October committee meeting. Cllr Gordon will then arrange for a representative of Hampshire Highways to meet with committee members to discuss this.

Cllr Gordon also read out a letter he had received from HCC highways which states that in the planned resurfacing works from 4<sup>th</sup> October onwards, only the first 15 metres of Nations Hill will be resurfaced. The remainder of the road is not being resurfaced due to the lack of reports and available funding.

# P/21/075 – Available Updates (if any)

- <u>Ecogen application –</u> The Clerk had been in contact the with case officer regarding the potential committee date. The Case officer is awaiting comments from the highways authority and this may result in the application being heard at the November regulatory committee meeting. The dates for the next two regulatory meeting are 20<sup>th</sup> October and 17<sup>th</sup> November respectively (as per HCC website).
- <u>Winchester City Council (WCC) Top Field development –</u> The Clerk had emailed Cllr Porter (HCC) and Cllr Prince (WCC) to ask for an update on the outstanding issues on the site.
- Land adjacent to Tudor Way Nothing further.

• <u>Contractor parking within the village –</u> It was agreed for Cllr Gordon to write to the head of planning at WCC to ask that conditions are placed on all permission in the parish to ensure there is an agreed enforced plan for parking.

It was also agreed for Cllr Gordon to write to HCC to ask why despite requests, contractors are not being allowed to park on the disused Cornerways site.

**Action –** Cllr Gordon to write to WCC and HCC as above.
