P/22/099 - Public question time

P/22/100 - To Consider Planning Applications received since the last Meeting 22/02053/FUL

9 Boyne Rise, Kings Worthy SO23 7RE

Demolition of existing dwelling and erection of replacement dwelling.

Response/Action - The Parish Council wish to support to this application.

22/02153/HOU

Ryecroft, 33 Springvale Road, Kings Worthy SO23 7ND

Replacement of existing roof with a higher pitch. Loft conversion to new roof space with rear dormer.

Response/Action - The Parish Council objects to this application on the following grounds:

 Visual impact – The proposed dormer is excessive in size and not in-keeping with the surrounding area. • Loss of amenity –The proposed dormer will impact the adjacent property causing both a loss of privacy and amenity.

22/02282/FUL and 22/02283/LIS

Cart and Horses, London Road, Kings Worthy SO23 7QN

Erection of 1 no. pergola; 1 no dining pod and external bar / servery; new areas of hard surfacing; extension of external seating area to front; replacement kitchen extract and ventilation system.

Response/Action – The Parish Council supports this application providing conditions are attached which ensure appropriate measures are taken to minimise noise and light pollution, and which ensure the comments of the Historic Environment Officer are addressed.

22/02298/TPO

South Ridge, Mount Pleasant, Kings Worthy SO23 7QU

Crown lift ash trees (T1 and T2) over garden and house to approximately 6m to maintain distance between trees and building and allow trees under canopy to develop.

Response/Action – The Parish Council are broadly in favour of this application but wish to defer this decision to the Arboriculture Officer.

P/22/101- Planning & Highways dashboard - to include planning decisions advised since the last meeting and enforcement notices

Members reviewed a copy of the dashboard including decisions issued by the relevant planning authorities (information is publicly available from the relevant authority).

21/00832/HCS - North Winchester Farm, Stoke Charity Road, Kings Worthy

Members noted that an additional technical report had been submitted by the applicant to Hampshire County Council. It was agreed, this did not address the Parish Council's concerns particularly regarding the safety of pedestrians and cyclists.

Mill Lane, Abbots Worthy - It was noted no progress had been made with repairs to the flint wall.

Lane East of Burnet Lane - Winchester City Council have responded to Shorewood homes.

P/22/102 - Agree and sign the minutes of the meeting held on the 23 August 2022

P/22/104 – Local Plan 2039 regulation 18 consultation – to include the Parish Council's response

Cllr Cossburn had attended the public consultation. The two proposed development sites put forward by the Parish Council have been incorporated into the Local Plan 2039 together with the proposed conditions. Members had no further comment to make.

Members considered the proposed resolution from IVPC seeking immediate changes to the Cart and Horses junction. It was agreed to ask Councillor Adams-King (Hampshire County Council - Exec Member for Highways Operations) for an in-person meeting as a top priority (option A).

Action: Clerk to obtain a date for a meeting with Cllr Adam-King as soon as possible; Headbourne Worthy Parish Council and Itchen Valley Parish Council also to attend.

- <u>Ecogen Application update including revised application documentation –</u> See above.
- 2-5 Tudor Way (inc. 132A Springvale Road) and Land To The East Of Burnet Lane planning applications including revised application documentation the revised design comprises 6x semi-detached and 1x detached property with an area of public open space. Members had no further comment.
- Speed sign deployment initiative A work order has been placed and fitment is awaited. There has been a problem with downloading the data from the speed sign. The software appears to be the cause. When more data is available a response will be sent to the detailed queries previously received by residents in Abbots Worthy.
