RA/24/053 – To agree and sign the Minutes of the Meeting held on 08 February 2024

The minutes of the previous meeting were then agreed as a true record of the meeting.

RA/24/054 - Matters arising from the meeting held on 07 February 2024

RA/24/055 - Eversley Park play area -

- <u>Update on tower installation</u> The Deputy Clerk noted that the parts have been installed and the tower is open.
 - After discussion, it was agreed that the invoice for Eversley Park play area would be paid if the Contractor agrees to pay the soil work from retention.
- <u>Update on zipline re-painting</u> The Deputy Clerk noted that the contractor informed us the zipline legs will be replaced due to a metallurgy issue preventing the payment sticking.
 - The Deputy Clerk noted that there was another Facebook comment regarding the guard rail on the zipline. The deputy Clerk gave a document to members about the zip wire manufacturer's response for posting on the website and Facebook page.

Action - Members will confirm if they are happy with the proposed update.

• <u>Movement of bench in Play area</u> – The Deputy Clerk noted that one of the Councillors saw the child at Eversley Park play area using the spinning bowl and almost fell to the bench.

Action - After discussion, it was agreed to take out the bench and the Deputy Clerk will obtain a quote from M.R.S. Services.

RA/24/056 - Fraser Road play area

- <u>Update on repair/installation works</u> The equipment has been ordered from Kompan and will arrive by 15th April.
- <u>Update on CCTV</u> The Deputy Clerk noted that we do not need planning permission for the pole under 4 metres.

The existing pole in the car park is a bit wobbly. The CCTV company suggested purchasing a wider, solid pole with a security collar.

Two options of pole:

A – painted pole - £145.00

B - power coated pole - £281.00

After discussion, it was agreed to purchase the painted pole which will cost £145.00.

• <u>Allotment access/parking</u> – The Deputy Clerk noted that we are still waiting response from Winchester City Council.
